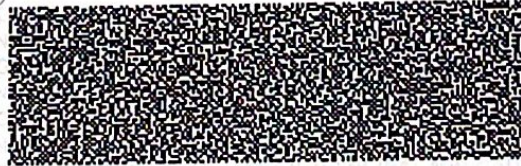


THE TERMS OF THE MOU ARE AS FOLLOWS


01. CADD Centre agrees to provide Faculty Members to conduct the Value Added Courses at M.C.E – CIVIL premises.
02. M.C.E – CIVIL agrees to provide Hardware facilities and Class rooms for conducting the Value Added Courses for the pay as agreed mutually by both parties.
03. The essential criteria for this MoU shall be timely assistance by M.C.E – CIVIL to CADD Centre.
04. The main objective of CADD Centre and M.C.E – CIVIL will be to impart quality Training/Education Services to the students of M.C.E – CIVIL.
05. CADD Centre shall make provision for modification, improvements or changes suggested by M.C.E – CIVIL and course fee variation will be on agreeable terms between both parties.
06. The duration of the MoU shall be for four years and shall be extended there after by mutual consent.
07. For all interactions and execution of this MoU, from M.C.E – CIVIL the H.O.D/PRINCIPAL will be the contact person and from CADD Centre, the Centre Head HASSAN will be the contact person.
08. CADD Centre will provide the course material/ Certificate/ Faculty members for each course which is intended to develop the knowledge of the students through the above said joint effort.
09. Through this agreement, Second year, Third year and Final year student of M.C.E– CIVIL will be given training in Modeling Software, Analysis Software and Real time project respectively.

10. The total training session will be for a time period of 40 hours to be completed in ODD SEM (July – Dec). In the subsequent EVEN SEM (Jan – Feb) a refresher course for 10 hours will be conducted.
11. The payment terms as agreed by both CADD centre and M.C.E-CIVIL. are as follows:
 - ❖ 50% of the course fees should be paid during the start of the course.
 - ❖ Remaining 50% of the course fees shall be paid by the completion of the course
12. Course fee and terms and conditions can be revised only with a mutual agreement between both the parties.
13. All the decisions should be made with the consent of the HOD/Principal, M.C.E Institute of Technology and center head, CADD centre, HASSAN.
14. Courses should be conducted only in the timings mutually agreed by both parties.
15. In addition to CADD center faculty members, M.C.E-CIVIL. will provide a faculty Coordinator and a supporting staff to run the course.
16. For the conduct of the whole course the Centre Head, CADD Centre, HASSAN will be the in charge.
17. It is also mutually agreed upon by both the parties that the courses once offered will be completed in all respects. Bothe the parties are responsible for the smooth conduct of the planned courses without causing any damage to the properties and any hardship to the students.
18. Course plan and the course material for the course must be approved by both parties well in advance and to be given to students in their first day of their course.
