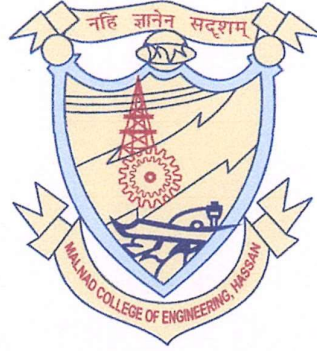

**13 Regarding provision of dearness allowance to unaided non-teaching employees.**

At present 45.25% dearness allowance is being given to aided non-teaching employees. But in our institution only 32.25% Dearness Allowance is being given to unaided non-teaching employees. The unaided employees have submitted a request for the remaining 13% Dearness Allowance.

If 13% dearness allowance is given, the difference in salary to be borne by the management is Rs.20,03,962/-
