Proceedings of the 116<sup>th</sup> meeting of the Board of Governors of Malnad College of Engineering, Hassan held on Saturday, the 2<sup>nd</sup> March 2019 at 11.00 A.M. in the Board Room, MCE, Hassan.

At the outset, the Principal and Member Secretary Dr. K.S. Jayantha welcomed the Chairman and members of the Board of Governors to the meeting and extended warm welcome to Dr. Reeta Sarmah, Principal of Jorhat Engineering College (Mentee Institution) for the first meeting & requested Sri. Ashok Haranahalli, Chairman, to preside over the meeting.

Principal briefed about the following events and activities of the college:

- Construction of Administration cum class room block based on the increase in intake and as per AICTE norms. Briefed the walkthrough of the plan of the proposed building.
- ➤ TEQIP ratings:
  - Principal informed that our Institute is one among the 32 colleges which has been shortlisted for best twinning activities and our college has scored 1 which is the best score. And thanked all the stake holders of TEQIP 1.3. and reciprocation and work which has been extended by the Mentee Institution JEC was very much appreciated and placed on records.
  - Hon. Chairman Sri. Ashok Haranahally thanked and placed on records the cooperation extended by the Jorhat Engineering College.
- Our Institute has submitted the action plan to Equity action plan of TEQIP and out of 32 colleges all over India, 9 colleges from Karnataka had submitted the action plan. Out of 9 colleges from Karnataka our college EAP has been recognized as Best Plan.
- Conducted International conference at JEC, Jorhat as a part of Twining activity which was held on 21<sup>st</sup> and 22<sup>nd</sup> December 2018. And informed that this was the 1<sup>st</sup> international conference conducted in entire North East among technical institutes and congratulated Principal, JEC for organizing the event and making it a grand success.
- Global Alumni Meet was held on 22nd of December 2019 in Bangalore in which 26 Engineering College Principal's and 4 Vice-chancellors who were alumnus of this institution were felicitated. A Proposal for the Establishment of Research Centre at Bangalore was mooted by renowned alumni and the same facility can also be utilized for Training and Placement activities too. Around 1200 alumni attended the program.
- Our Institution was awarded 3<sup>rd</sup> Place among state level Cloud Literary Day held on 31<sup>st</sup> December 2019 at Chennai. The dedicated efforts of ME-RIISE team was appreciated and placed on records.

- VTU-LIC visit was held on 9<sup>th</sup> January 2019, where it was requested for increase in intake for 3 branches and inspection has been successfully completed and awaiting for the report.
- Principal informed that 5 villages (Heragu, Dudda, Gopanahalli, Anagavalli, Lingarasanahalli) are adopted under Unnath Bharath Abhyiyan and the UBA team has done initial visits and the survey is completed. Further the work is co-ordinated with our NSS students with authorities of Zilla panchayath and office of Deputy commissioner. The first 2 survey / visits is completed with regard to literacy, basic facilities, hygienic, environmental protection, communication skills. Establishment of internet facility, awareness about computers, field work etc., the UBA activities will be held.
- New bus has been purchased on 17<sup>th</sup> January 2019. After the completion of the registration process, the old bus will be handed over to the Malnad Hippcampus school.
- Republic Day was celebrated on 26<sup>th</sup> January and it was informed that many of the students with highest number of blood donors were felicitated with Gold Medal and informed that the same tradition will be continued in National festivals.
- Commissioning of sewage treatment plant in campus with a capacity of 1 lakh liters, is completed and 1972 batch alumni have donated 3.1 lakhs for the same.
- Submission of FIST action plan for the first phase of action is done on 4<sup>th</sup> February 2019 and approval for the same is expected
- Condolence to our Soldiers was conducted on 18th February 2019 with regard to Pulwama attack.
